At any time, an additional 20% of adults in the United States suffer from temporary pain. The search for a non-addictive solution has led to thoroughly examining CBD for treating chronic pain in extensive clinical studies.

The National Health Interview Survey found that 50.2 million adults (20.5%) in the United States reported pain on most days or every day. *Prevalence of chronic pain among adults in the United States: PAIN 163(2):p e328-e332, February 2022.* "Chronic pain is associated with reduced quality of life, increased medical expenditures, and significant economic costs."
